DECLARATION OF AARON ETTINGER

- Aaron Ettinger, declare as follows:
- 1. I am making this Declaration in support of the letter written by POA
 Counsel Gregg Adam to City Manager Ed Shikada on Wednesday, October 22,
 2014 concerning allegations against POA President Jim Unland. I am familiar with
 the facts set forth in this Declaration. If called as a witness, I could and would
 testify competently to these facts.
- 2. I was a resident of the City of San Jose until I was approximately 19 years old. I then bought a condominium in Milpitas. I was then a resident of Milpitas until 18 months ago, when I moved back to San Jose. I have been a small business owner since 1999. My current business is in the communications industry and is based in San Jose.
- 3. I had a longstanding dream of becoming a full-time police officer for the San Jose Police Department. To further that dream, beginning in January 2008, I put myself through the Police Academy, bearing all costs directly. I was accepted as a Reserve Police Officer for the San Jose Police Department in May 2008 and worked in that capacity from approximately October 2008 until April 2014. I worked hundreds of hours of voluntary unpaid duty during that time period.
- 4. In order to become eligible to apply to become a full-time police officer, I also went back to college for one year, taking five and six classes per semester in order to get sufficient credits.
- 5. I graduated from the Academy, and effective April 13, 2014, I was selected as a Direct Entry Police Officer. I was a Tier 2 Police Officer under the City Charter.

Mr. Ajlouny told me to not say anything about getting a lawyer involved or the chiefs would "clam-up" and not talk to me. If the Chief would not give me my job back, then Mr. Ajlouny told me that I should call him (Ajlouny) if I was prepared to meet with him, Mayor Reed and an attorney. He mentioned that the discussion with the Mayor would concern some type of legal action to be filed against the POA. He asked me if I "wanted to make some money." I took this to mean that I would be paid or receive money for being part of some type of legal action against the POA. At that moment, I told Mr. Ajlouny that I was not looking to be paid.

17. I told Mr. Ajlouny that I would think over the weekend about whether I would go to see the Department to ask for my job back. I thought about the subject over the weekend and decided not to pursue any action.

I declare under penalty of perjury that the foregoing is true and correct.

effect that he ran political campaigns, including for San Jose Mayor Chuck Reed.

Mr. Ajlouny then asked: "Do you want your job back?" I took him to be meaning my former full-time San Jose police officer job, and I responded that of course I wanted the job but because of Measure B, I did not want it back full-time because there is no guaranteed pension or medical disability retirement. Instead, I advised Mr. Ajlouny that I wanted my unpaid Reserve Officer position back.

- published about a female recruit being told by Sergeant Unland to quit. He advised me that he wanted me to collaborate with him and the female recruit; specifically about the Police Officers' Association and Mr. Unland trying to get officers to quit. He indicated that "they" were tired of "Unland lying to people." He then told me: "I'm trying to get Jim Unland's ass fired." Ajlouny said that "Jim has lied to you, Aaron." I disagreed with him about Jim Unland lying to me, and told him that Jim had told me that pension and disability benefits could get worse before they get better and that the pension was not guaranteed. Mr. Ajlouny argued with me about whether the second tier pension was guaranteed or was subject to change. He mentioned it would have to go back to the voters to be altered.
 - I told Mr. Ajlouny that Mr. Unland did not tell me to quit.
